# The Wisconsin Youth Symphony Orchestras

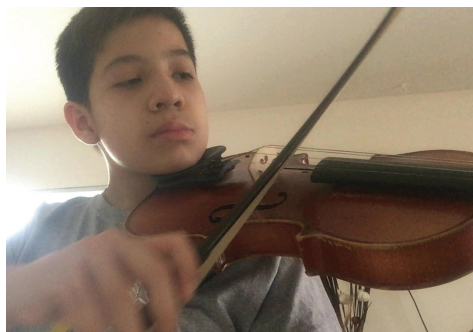

<b>What is it?</b>	A donation of cash, securities, and most gifts of real estate	A gift where you name WYSO as a beneficiary of a part, or all, of your retirement account	A gift of an old or new policy with WYSO named as beneficiary	A gift you make to WYSO in your will	A trust that pays you, or other individual beneficiaries, a set income before WYSO receives the remainder	A trust that pays you, or other individual beneficiaries, a variable income before WYSO receives the remainder	A contract in which WYSO agrees to pay back a percentage of your gift annually for your lifetime	A trust that pays WYSO an income for a period of years before you or your heirs receive the remainder
<b>What are the tax benefits?</b>	Income tax deduction for the value of the gift plus no capital gains tax due on appreciation of the property	WYSO is a tax exempt organization and can receive full value of gift	Immediate income tax deduction for gift's value plus possible estate tax savings	Estate tax deduction for the value of your bequest to WYSO	Income tax savings from deduction, no capital gains tax liability, and possible estate tax savings	Income tax savings from deduction, no capital gains tax liability, and possible estate tax savings	Immediate income tax deduction for part of gift's value, with capital gains spread out over life expectancy	Gift of estate tax savings for the value of payments made to WYSO
<b>What are some other benefits?</b>	Permits you to tailor your gift for WYSO's immediate needs. Cash gifts may be pledged over a period of five years to maximize your contribution	A beneficiary designation is easily updated, generally without having to incur legal expenses, and allows your gift to flow directly to WYSO and not through your will	Provides a way to make a significant gift with little expenditure	Allows flexibility in providing for family needs first	Provides fixed annual income for donor or other beneficiary regardless of market conditions	Provides fixed annual income that would increase if trust value increases	Gives you and/or another beneficiary a set income for life	Allows donors to pass assets to heirs intact at a reduced cost
